On the basis of the performance of CBT held from 19.07.2019 to 21.07.2019 and followed by verification of the documents held from 19.09.2019 to 21.09.2019 and 23.09.2019 (For Absentee Candidates) and on being found medically fit, the candidates with the following Roll Numbers have been provisionally empanelled against the post of Paramedical Categories (Category No. 6,11 & 15) under CEN-02/2019.
2. This is Provisional Part Panel for Category-06(Health & Malaria Inspector Grade-III), Category-11(Pharmacist Grade-III) and Category- 15 (Lady Health Visitor) under CEN No. 02/2019. The Provisional Panel of remaining candidates of Post Code 06 & 11 and of the Category 2 (Staff Nurse), Category-10 (Physiotherapist), Category 12 (Radiographer) & Category-16 (Lab Assistant Grade-II) shall be issued later on.
3. Result of certain number of candidates who have not been successfully completed DV and/or Medical Examination on account of some pending clarification etc are being Withheld. Based on the Suitability/Unsuitability of these candidates on account of their submitted documents, their result will be updated on RRB Website in due course of time.

Candidature of all the candidates appearing in this Part Panel is purely provisional and is liable to be cancelled in case of any inconsistency/deficiency of the data furnished by them in the online application or any mal-practice on the part of candidate coming to the notice of RRB at any stage of appointment/recruitment process. It may be noted that merely getting placed in the Provisional Part Panel does not entitle her/him in any way to an appointment in the Railway.
5. While every care has been taken in preparing this Provisional Part Panel, RRB reserve the rights to rectify any inadvertent error or typographical/printing mistakes.
6. The Roll No. of candidates of this provisional part panel are arranged horizontally in ascending order and not in order of merit for each category/post.

The name of candidates of this Provisional Part Panel are being forwarded as the case may be to Principal Chief Personnel Officer, North Central Railway, Subedarganj, Prayagraj, Principal Chief Personal Officer, Northern Railway, Baroda house, New Delhi & Principal Chief Personal Officer, DLW, Varanasi. Further course of action on their appointment will be taken by Principal Chief Personnel Officer, N. C. Railway, Northern Railway and DLW after due verification & ensuring fulfilment of eligibility criteria like production of Original/Current Certificates of Educational/Technical Qualification, Date of Birth, Caste Certificates, Past Character/antecedents/Affidavits where necessary etc according to the Centralised Employment Notice No. 02/2019 and corrigendum issued thereto from time to time and for which the candidates will be informed individually by the N. C. Railway, Northern Railway and DLW. All candidates will be required to submit an affidavit that their Degree/Diploma certificate and Caste certificate, as the case may be, are genuine and valid.
